

**AMENDMENT NUMBER TWO (2) TO THE
AGREEMENT BETWEEN FIU AND HOTEL**

This Amendment No. Two to the Agreement (the “**Amendment**”) is entered into on this 14th day of December, 2018____ (the “**Effective Date**”), by and between **The Florida International University Board of Trustees**, a public body corporate (“**FIU**” or “**University**”), for and on behalf of its various departments and colleges (“**Department**”) and **PROCACCI DOLPHIN, LLC** a Florida limited liability company, doing business as **HILTON GARDEN INN MIAMI DOLPHIN MALL**, whose address is 1695 111TH Avenue, Miami, FL 33172, who is authorized to do business in the State of Florida (the “**Hotel**”).

WHEREAS, the FIU and the Hotel entered into that Master Hotel Agreement dated **August 16, 2017** for accommodations, meeting space, and/or services for events; as amended by that certain Amendment One to the Agreement dated **February 6, 2018** (the “**Agreement**”);

WHEREAS, the parties desire to amend the Agreement as set forth herein.

NOW THEREFORE, for and in consideration of the covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to modify the original agreement as follows:

1. Amendment. The Maximum Rate Schedule outlined in Section 17 – Rate Schedule in the Agreement, dated August 16, 2017 and Amendment One to the Agreement dated February 6, 2018, is hereby amended as follows for the period of **January 1, 2019** thru **December 31, 2019**. All blackout dates and amenities listed below shall apply for the period of January 1, 2019 through December 31, 2019. All other terms and conditions shall remain the same.

3. Conflict. In the event of a conflict between the terms of this Amendment and the Agreement, the terms of this Amendment shall control.


4. Capitalized Terms. All capitalized terms used herein but not expressly defined herein shall have the meaning ascribed thereto in the Agreement.
