

**AMENDMENT NO. THREE (3) TO THE  
AGREEMENT BETWEEN FIU AND HOTEL**

This Amendment No. Three (3) to the Agreement (the “**Amendment**”) is entered into on this 16th day of November, 2018 (the “**Effective Date**”), by and between **The Florida International University Board of Trustees**, a public body corporate (“**FIU**” or “**University**”), for and on behalf of its various departments and colleges (“**Department**”) and **MIA LeJeune, LLC**, a **Florida limited liability company**, doing business as **Hyatt Place Miami Airport East**, whose address is 3549 Le Jeune Rd, Miami, FL 33142 (the “**Hotel**”).

**WHEREAS**, the FIU and the Hotel entered into that Master Hotel Agreement dated **May 16, 2016** for accommodations, meeting space, and/or services for events; as amended by that certain Amendment Agreement dated **December 28<sup>th</sup>, 2016**; as further amended by that certain Amendment Two to the Agreement dated **December 27<sup>th</sup>, 2017** (Collectively, the “**Agreement**”);

**WHEREAS**, the parties desire to amend the Agreement as set forth herein.

**NOW THEREFORE**, for and in consideration of the covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to modify the original agreement as follows:

**1. Amendment.** The Maximum Rate Schedule outlined in Section 17 – Rate Schedule in the Agreement dated May 16, 2016, Amendment Agreement dated December 28<sup>th</sup>, 2016 and Amendment Two to the Agreement dated December 27<sup>th</sup>, 2017, is hereby amended as follows for the period of **January 1, 2019** thru **December 31, 2019**. All blackout dates listed below shall apply for the period of January 1, 2019 through December 31, 2019. All other terms and conditions shall remain the same.


