

## ADDENDUM

**THIS ADDENDUM** to the Master Agreement (the "Addendum") is made and entered into on the last date signed below (the "Effective Date"), by and between **THE FLORIDA INTERNATIONAL UNIVERSITY BOARD OF TRUSTEES** ("FIU") and **Right Human Resource Consultants, Inc. & Organizational Consultants, Inc. DBA: Right Management**, a Florida Corporation, whose address is 1301 E. Broward Blvd., #200 Ft. Lauderdale FL 33301-2111 who is authorized to do business in the State of Florida (the "Contractor").

**WHEREAS**, FIU and Contractor entered into that certain Master Agreement between FIU and Contractor dated **February 04, 2020** (the "Master Agreement") pursuant to **ITN# 2019-00013** to provide **HR Multi Level Coaching, Training & Consulting Services**, to support initiatives within the following areas on a consulting basis, as requested by FIU: Executive and multi-level coaching, Strategy development/alignment, Organizational culture assessment & alignment, Mission & vision work, Leadership retreat planning, development & facilitation, Leadership development content design & facilitation, Train-the-trainer services; Project Management and any other additional Specialized Administrative Areas not specifically listed by but requested by FIU throughout the term of this Master Agreement (the "Services"); as amended and renewed (collectively, the "Agreement").

**WHEREAS**, FIU has requested Contractor to provide the Services pursuant to the Master Agreement related to the following: brief description of Engagement (this "Engagement");

**WHEREAS**, Contractor and FIU have agreed to the following specific terms for this Engagement;

**NOW THEREFORE**, for and in consideration of the covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to modify the Master Agreement as follows:

1. **Ratification**. The Master Agreement remains in effect and unchanged, and the terms herein are in addition to the terms and conditions stated in the Master Agreement.
2. **Term**. Performance of the Services related to this Engagement shall begin on (enter date), and shall end on the earlier of (i) (enter date), or (ii) when the Engagement Services are complete (the "Engagement Term").

8. **No counterparts; facsimile signatures allowed.** This Addendum may not be executed in counterparts. This Addendum, along with any and all Exhibits, may be executed and delivered by facsimile signature by any of the parties to the other parties; to the extent permissible under Florida law, a facsimile signature shall have the same legal force and effect as an original signature and the receiving party may rely on the receipt of such document so executed and delivered by facsimile signature as if the original had been received.
