

**AMENDMENT NUMBER SIX (6) TO THE  
AGREEMENT BETWEEN FIU AND HOTEL**

This Amendment Six (6) to the Agreement (the “**Amendment**”) is made and entered into on the last date signed below (the “**Effective Date**”), by and between **The Florida International University Board of Trustees**, a public body corporate (“**FIU**” or “**University**”), for and on behalf of its various departments and colleges (“**Department**”) and **Provident Doral Resorts, LLC**, a **Florida company**, doing business as **Provident at the Blue**, whose address is 5300 NW 87<sup>th</sup> Avenue, Miami, Florida 33178 (the “**Hotel**”).

**WHEREAS**, the FIU and the Hotel entered into that Master Hotel Agreement dated **March 12, 2015** for accommodations, meeting space, and/or services for events; as amended by that Amendment Agreement dated **February 11, 2016**; as further amended by that Amendment Two dated **December 27, 2016**; as further amended by that Amendment Three dated **January 3rd, 2018**; as further amended by that Amendment Four (4) dated **December 18, 2018**; as further amendment by that Amendment Five (5) dated **December 18, 2019** (Collectively, the “**Agreement**”);

**WHEREAS**, the parties desire to amend the Agreement as set forth herein.

**NOW THEREFORE**, for and in consideration of the covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to modify the original agreement as follows:

**1. Amendment.** The Maximum Rate Schedule outlined in Section 17 – Rate Schedule in the Agreement dated March 12, 2015, Amendment Agreement dated February 11, 2016, Amendment Two to the Agreement dated December 27, 2016, Amendment Three dated January 3rd, 2018, Amendment Four (4) dated December 18, 2018 and Amendment Five (5) dated December 18, 2019, is hereby amended as follows for the period of **January 1, 2021** thru **December 31, 2021**. Blackout dates shall apply for the period January 1, 2021 through December 31, 2021. All other terms and conditions shall remain the same for the period listed above.
