

**AMENDMENT NO. FIVE (5) TO THE
AGREEMENT BETWEEN FIU AND HOTEL**

This Amendment No. Five (5) to the Agreement (the “**Amendment**”) is entered into and made on the last date signed below (the “**Effective Date**”), by and between **The Florida International University Board of Trustees**, a public body corporate (“**FIU**” or “**University**”), for and on behalf of its various departments and colleges (“**Department**”) and **LCP HIALEAH OPERATING GROUP, INC.**, Delaware Corporation, doing business as **HOLIDAY INN MIAMI WEST**, whose address is 7707 NW 103rd Street, Hialeah Gardens, FL 33016 (the “**Hotel**”).

WHEREAS, the FIU and the Hotel entered into that Master Hotel Agreement dated **May 6, 2016** for accommodations, meeting space, and/or services for events; as amended by that Amendment Agreement dated **January 11, 2017**; as amended by that Amendment Two (2) to the Agreement dated **January 4, 2018**; as amended by that Amendment Three (3) to the Agreement dated **November 16th, 2018**; as amended by that Amendment Four (4) to the Agreement dated **December 19, 2019**, (Collectively, the “**Agreement**”);

WHEREAS, the parties desire to amend the Agreement as set forth herein.

NOW THEREFORE, for and in consideration of the covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to modify the original agreement as follows:

1. Amendment. The Maximum Rate Schedule outlined in Section 9 – Rate Schedule in the Agreement, Amendment to the Agreement dated January 11, 2017, Amendment Two (2) to the Agreement dated January 4, 2018, Amendment Three (3) to the Agreement dated November 16th, 2018 and Amendment Four (4) to the Agreement dated December 19, 2019, is hereby amended as follows for the period of **January 1, 2021** thru **December 31, 2021**. No blackout dates listed below shall apply for the period of January 1, 2021 through December 31, 2021. All other terms and conditions shall remain in effect.
