

**AMENDMENT NUMBER SEVEN (7) TO THE
AGREEMENT BETWEEN FIU AND HOTEL**

This Amendment Six (6) to the Agreement (the “**Amendment**”) is made and entered the last day signed below (the “**Effective Date**”), by and between **The Florida International University Board of Trustees**, a public body corporate (“**FIU**” or “**University**”), for and on behalf of its various departments and colleges (“**Department**”) and **AFP Management Corp**, a Nevada corporation, on behalf of **DoubleTree Miami Airport**, whose address is 711 NW 72nd Avenue, Miami, FL 33126, who is authorized to do business in the State of Florida (the “**Hotel**”).

WHEREAS, the FIU and the Hotel entered into that Master Hotel Agreement dated **March 6, 2015**, for accommodations, meeting space, and/or services for events; as amended by that Amendment Agreement dated **February 11, 2016**; as further amended by that Amendment Agreement Two (2) dated **January 30th, 2017**; as further amended by that Amendment Agreement Three (3) dated **January 11th, 2018**; as further amended by that Amendment Agreement Four (4) dated **December 4th, 2018**; as further amended by that Amendment Agreement Five (5) dated **December 18, 2019** ; as further amended by that Amendment Agreement Six (6) dated **December 10, 2020** (Collectively, the “**Agreement**”);

WHEREAS, the parties desire to amend the Agreement as set forth herein.

NOW THEREFORE, for and in consideration of the covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to modify the original agreement as follows:

1. Amendment. The Maximum Rate Schedule outlined in Section 17 – Rate Schedule in Amendment Two dated January 30th, 2017; Amendment Three dated January 11th, 2018, Amendment Agreement Four (4) dated December 4th, 2018, Amendment Agreement Five (5) dated December 18, 2019 and Amendment Six (6) dated **December 10, 2020**; is hereby changed as follows for the period of **January 1, 2022** thru **December 31, 2022**. No blackout dates shall apply for the period of January 1, 2022 through December 31, 2022. All other terms and conditions shall remain the same in full effect.

4. Capitalized Terms. All capitalized terms used herein but not expressly defined herein shall have the meaning ascribed thereto in the Agreement.
