

# AMENDMENT NUMBER SEVEN (7) TO THE AGREEMENT BETWEEN FIU AND HOTEL

This Amendment No. Seven (7) to the Agreement (the "<u>Amendment</u>") is made and entered on the last date signed below "<u>Effective Date</u>"), by and between **The Florida International University Board of Trustees**, a public body corporate ("<u>FIU</u>" or "<u>University</u>"), for and on behalf of its various departments and colleges ("<u>Department</u>") and <u>Hotel Genpar, LTD</u> a <u>Florida limited liability company</u>, doing business as <u>InterContinental at Doral Miami</u>, whose address is <u>2505 NW 87<sup>th</sup> Avenue</u>, <u>Miami</u>, <u>Florida</u>, <u>33172</u>, (the "<u>Hotel</u>").

WHEREAS, the FIU and the Hotel entered into that Master Hotel Agreement dated <u>March 6, 2015</u> for accommodations, meeting space, and/or services for events; as amended by that Amendment Agreement One (1) dated <u>February 18, 2016</u>; as further amended by that Amendment Agreement Two (2) dated <u>January 12, 2017</u>; as further amended by that Amendment Three (3) Agreement dated <u>February 6, 2018</u>; as further amended by that Amendment Four (4) Agreement dated <u>November 30, 2018</u>; as further amended by that Amendment Five (5) Agreement dated <u>December 20, 2019</u>; as further amended by that Amendment Agreement Six (6) dated <u>December 18, 2020</u> (Collectively, the "<u>Agreement</u>");

**WHEREAS**, the parties desire to amend the Agreement as set forth herein.

**NOW THEREFORE**, for and in consideration of the covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to modify the original agreement as follows:

1. Amendment. The Maximum Rate Schedule outlined in Section 17 – Rate Schedule in the Agreement, Amendment (1) Agreement dated February 18, 2016, Amendment (2) Agreement dated January 12, 2017, Amendment Three (3) Agreement dated February 6, 2018, Amendment Four (4) Agreement dated November 30, 2018, Amendment Five (5) Agreement dated December 20, 2019 and Amendment Six (6) dated December 18, 2020; is hereby amended as follows for the period of January 1, 2022 thru December 31, 2022. All blackout dates listed below shall apply for the period of January 1, 2022 through December 31, 2022. All other terms and conditions shall remain the same.
