

AMENDMENT NO. SEVEN (7) TO THE

AGREEMENT BETWEEN FIU AND HOTEL

This Amendment to the Agreement No. Seven (7) (the "<u>Amendment</u>") is made and entered into on the date signed below (the "<u>Effective Date</u>"), by and between **The Florida International University Board of Trustees**, a public body corporate ("<u>FIU</u>" or "<u>University</u>"), for and on behalf of its various departments and colleges ("<u>Department</u>") and <u>APPLE SEVEN HOSPITALITY MANAGEMENT, INC...</u> a Virginia Corporation, doing business as <u>COURTYARD BY MARRIOTT AT THE DOLPHIN MALL</u>, whose address is 11275 NW 12TH Street, Miam<u>i</u>, FL 33172, who is authorized to do business in the State of Florida (the "<u>Hotel</u>").

WHEREAS, the FIU and the Hotel entered into that Master Hotel Agreement dated <u>May 20, 2016</u> for accommodations, meeting space, and/or services for events; as amended by that certain Amendment Agreement dated <u>December 30, 2016</u>; as further amended by that certain Amendment Two (2) dated <u>December 18, 2017</u>; as further amended by that certain Amendment Three (3) dated <u>December 4, 2018</u>; as further amended by that certain Amendment Four (4) dated <u>December 17, 2019</u>, as further amended by that certain Amendment Five (5) dated <u>April 22, 2021</u>; as further amended by that certain Amendment Six (6) dated 12/15/2021 (Collectively, the "<u>Agreement</u>");

WHEREAS, the parties desire to amend the Agreement as set forth herein.

NOW THEREFORE, for and in consideration of the covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree to modify the original agreement as follows:

1. Amendment. The Maximum Rate Schedule outlined in Section 9 – Rate Schedule in the Agreement, Amendment Agreement dated December 30, 2016, Amendment Agreement Two (2) dated December 18, 2017, Amendment Agreement Three (3) dated December 4, 2018, Amendment Agreement Four (4) dated December 17, 2019, Amendment Agreement Five (5) dated April 22, 2021 and Amendment Six (6) dated December 15, 2021 is hereby amended as follows for the period of January 1, 2023 through December 31, 2023 All blackout dates listed below shall apply for the period of January 1, 2023 through December 31, 2023. All other terms and conditions shall remain in effect.
